REMEMBERING THE PAST:

ELLSWORTH'S POST OFFICES/POSTMASTERS

Ellsworth has had several locations for its post offices over the years, primarily on Main Street. The first post office was situated where the current one stands. Initially, it was a general store. Later, it was relocated to a building further south on the same street.

Next, the post office moved to the site of the NE corner of Dubuque and DeWitt Sts but unfortunately, the building later burned down. In 1906, it operated in the south half of a building that previously housed Thompson's Turkey Hatchery on DeSota St. Subsequently, it returned to Main Street, occupying the back of the then-State Bank Building, NW corner of DeWitt and Dubuque. Later, the post office moved into the rooms vacated by the State Bank when the Bank closed.

In 1962, Wayne Brinton constructed a new building north of the Legion Hall. This building is currently leased by the government.

Halloween: Halloween went well with serving 240 hot dogs and having parents and children coming and going all night. The fire department said we could use their grill next year for the hot dogs.



PUBLIC FORUM: Darlene Campbell was present to discuss concerns about the youth in Ellsworth not following safety or traffic rules when on electric bikes and scooters. Mayor Yager mentioned that this topic was on the agenda and that the Council would discuss it in depth. Travis Anderson was present to discuss the teardown and setup of tables and chairs in the Community Center gym. He shared that the four to five basketball teams using the gym over the winter months, each paying \$100, should offset any expense of hiring someone or a couple of people to tear down and set up the tables/chairs and take up the big floor mats.

SOUTH HIGH PRIDE ELLSWORTH GYM USE: Justin and Megan Thompson are spearheading the South High Pride Tournament on February 7th and asked for the use of the gym from 8 am to 6 pm. They said the Ellsworth Community Association could run the concession stand as a fundraiser. Motion by Olson and second by Phipps to allow the use of the gym free of charge and to cancel Bingo on February 7th. Roll call votes 3-0. Motion carried.

MAVERIK SIGN PERMIT APPLICATION: Motion by Phipps and seconded by Olson to approve the sign permit. Roll call votes 3-0. Motion carried.

THOMPSON CONSTRUCTION INVOICE FOR SCHOOL ROOF \$39,525.20: After balances in Bingo and Community Center were shared by Clerk Eckers, and discussion was had about lowa Code usage of gambling funds, motion made by Phipps and seconded by Funk to approve the payment of the invoice for Thompson Construction to replace the roof on the historic school building for \$39,525.20 out of Bingo funds. Roll call votes 3-0. Motion carried.

FUNK FUNNY FARM ANIMAL VARIANCE REQUEST: Tabled

PUBLIC HEARING CITY SALE OF PARCEL 40872330311008: Mayor Yager opened the public hearing at 6:56 pm. None present. Mayor Yager closed the public hearing at 6:57 pm.

RESOLUTION 10-28-2025 APPROVING THE TRANSFER OF REAL ESTATE TO LOGAN PRIME AND AUTHORING EXECUTION OF DEED: Motion by Phipps and second by Olson to adopt Resolution 10-28-2025. Roll call votes 3-0. Motion carried.

E-BIKE ORDINANCE DISCUSSION: Iowa Code 321.235A concerning electric personal devices was presented to the council after several citizen complaints about the use of these devices in town by young children. Ordinance No. 2025-06 from Humboldt, Iowa, was also presented as a potential example for Ellsworth to consider adopting. Council discussed definitions and types/classes of these electric vehicles. Council discussed the need for local governance that could be enforced by local law enforcement. Motion by Funk and second by Phipps that Clerk Eckers work with City Attorney Heeren on preparing an ordinance for the City of Ellsworth similar to Humboldt's 2025-06. Roll call votes 3-0. Motion carried.
